Instructional Materials Selection and Adoption for 2022-2023

Dr. Grens introduced the following members of the Learning and Teaching Department to assist with the presentation, Dr. Leonard, Ms. Leuschel, and Ms. Lyons. In accordance with Board of Education (BOE) Policy 6:210, Instructional Materials Selection and Adoption, they provided an overview of the annual Process for Display of Instructional Materials for ELA, SEL, and World Languages. This included student and teacher analysis, along with examination of research based best practices. The items for recommendation for the 2022-2023 school year will be on display for a period of 30-days. After the display period of 30 days, an update for approval will appear on the April 12, 2022 BOE meeting agenda.

Dr. Campbell thanked the team and indicated that as a learning organization we continue to have a need to reflect on the continuous support of teacher resources. The Board asked some clarifying questions and comments regarding the student and teacher data slides, IAR information, sharing of best practices, and the availability to review instructional materials.

Summer Programming Update

Before Dr. Rubenstein presented, Dr. Campbell indicated that in our learnings from last summer we realized an opportunity to coordinate and align a compressive summer programming to offer to support all of our students. Dr. Rubenstein provided a summary of the progress made on a unified summer program for students. The Board asked about bussing students for summer school.

SY 21-22 Moving Forward Together Update and COVID Metrics

Dr. Campbell reported that on Thursday, February 17, 2022, the Appellate Court for the Fourth District in Illinois noted that the issues in the appeal filed by Governor Pritzker and other defendants in the case known as Austin vs. Pritzker were moot since the Joint Committee on Administrative Rules (JCAR) had failed to approve a new set of rules for the Illinois Department of Public Health and the Illinois State Board of Education. Since February 7, 2022, it was communicated to students and staff in our schools that masks are strongly recommended, but not required. The decision to wear a mask during the day, including by adults, is a personal one and the District does not interfere one way or another with these decisions. We have worked with our building leaders to ensure that all students and staff feel supported regardless of whether they choose to wear a mask or not. We continue to echo the necessity of fostering a climate of respect and acceptance for all community members, regardless of vaccination status or views on masking. Dr. Campbell continued by summarizing our continued layered mitigations. The Board indicated the measures in place are good but would like to see the lunch procedures re-evaluated.
