A lot of people have been throwing around statistics about how 3 feet of distancing may be safe enough to prevent the spread of COVID-19 and that schools can be safely kept open during high rates of community transmission. I know no one wants to hear it, but 1'd like to point out that the data from Wisconsin was collected from RURAL Wisconsin classrooms with between 11-20 students. Sadly, I don't see too many classes of less than 20 students in our district. Students were in cohorts, i.e. not changing classes, and discouraged from mixing outside the classroom. They wore masks at all times when within 6 feet of each other and were at least 6 feet apart while eating. In North Carolina, the data was collected during 9 weeks of HYBRID only teaching. An astonishing 3000 students and staff were quarantined during the study period. These were observational studies and relied on surveys, and the data are not necessarily generalizable to any and all schools. Can we get away with 3 feet? Maybe. Are we going to have more quarantines? Probably. I can't tell from the dashboard what grade levels are affected, but the most recent update reflects we have 345 students on quarantine. up from 217 the week before. That's the most since September. We have 21 COVID-19 positive students, up from 6 the week before, and our middle school and high school kids haven't even gone back full time yet. They spent last summer installing air filtration systems and making the necessary spacial adjustments to house a significant increase in student population. We were not the only ones who moved their full-time residence seeking in-person schooling.
		I feel so fortunate that 2 of my children have thrived in full-time, in person public school since August. Everyone wears masks and they learn, play, eat lunch, have clubs and have enjoyed a very enriched year in Wisconsin.
		Having 2 happy children in school also magnified the tremendous academic and social-emotional stress that my 7th grader was experiencing with remote school via Bryan. She watched her brother and sister return every day from school at 3:00 and by winter break, she made the very difficult decision to switch to our Wisconsin school. 		First, I will let you know about my family – my husband and I moved here 3 years ago and chose Elmhurst for the amazing schools and location. We have 2 boys, 1 is in preschool at Immaculate Conception, and we have a 1st grader in the district. Our extended family is in Ohio with children ranging from Preschool age to Junior High.
		Next, let me say I don't envy you. You are all in a position where you have to appease multiple parties, and ultimately someone is never going to be happy. We have teachers and school staff that want to make sure that their work environment is safe, we have parents that want their children back in school full time 5 days a week, parents who want their kids to be home and for schooling to remain remote, parents think the best option lies in the middle, and our kids who are being forced to do whatever the adults decide. Our kids, especially the younger ones, are looking to us to figure out how to react to the ever-changing pandemic world, and I think a lot of the time, we forget them and the amount of adaptation and flexibility they have shown this past year.
		Our kids have been asked to take on tremendous changes this year – an abrupt ending to the 2019/2020 school year, a summer where pools and parks where closed, a summer where they couldn't see their friends and if they did it was a wave from the end of the driveway, but they had hope that in the fall they would be able to head back to school and see their friends. Unfortunately, we started the school year in full remote, and the excitement of the 1st day of school and getting to see your friends, just wasn't the same. We went to hybrid and most kids were ecstatic to be able to finally meet their teacher and put a person to the face on the computer screen and to see some of their friends, even masked. Then we went back to remote and the kids were again asked to sit and look at a computer screen for 5 hours a day. We switched their schedules again, and we went back to hybrid and finally 5 days a week (for most of our kids). Look at all those changes our kids had to endure, and they have handled it with more grace and flexibility than most adults, myself included.
		I am asking that going forward (immediately) we return to full in person schooling for all of our students. We need to provide them with a schedule that is not ever changing, we need to provide them with stability, we need to show them leadership and creativity. Science has shown that schools are not high transmission areas, let us follow the science. Let us help our children thrive!
		I am also asking that for next school year we recognize the difficulty that teachers face with teaching to both in class students and remote students. It is not fair to our teaching staff nor our students to have to navigate both the in-person and remote learning environment. Both environments require vastly different skills for teaching and learning. Please consider splitting classes up based on in-person and remote options, so that our teachers can help our students excel regardless of their choice of schooling. Please put all our students (in person and remote) first.
		I know that schools are safe as the science says so, and I have seen it at IC in our community and I have seen it within my family in Ohio whose children are attending public school full time since August 2020.
		The goal shouldn't be to get our kids back to school 100%, that is our duty as a community and your duty as the board and administration. Our goal should be how can we allow our kids to thrive while in school.

		My comments concern the safe reopening of D205 schools, and, in-particular, indoor air quality and ventilation. I have noticed this topic missing from most of the school opening discussions in our community. I realize it's a behind-the-scenes thing, but vitally important to healthy reopening plans.
		Regarding the COVID update document being reviewed at tonight's meeting, I do not see anything listed about indoor air quality or HVAC system functioning in the list of safety measures you are implementing at D205 schools. This is concerning to me because COVID is airborne and to-date, has not been proven to spread via fomites on surfaces as much as via aerosol particles.
		I understand that masks will still be required, but not everyone wears high-filtration masks, which are more effective at blocking aerosols than cloth masks. Of particular concern with going to full school days is the safety of the lunch areas when masks will need to be removed while students are eating.
		I've heard several D205 teachers and staff say that many or most windows do not open to allow fresh air to enter the classrooms.
		What upgrades will D205 be implementing before the re-opening to address indoor air quality, and how will these upgrades be assessed in each classroom? Will you be able to achieve the recommended 4-6 air changes/per hour per classroom? Same question for the eating areas? Will you be using portable HEPA filters in classrooms to increase clean air? Will you be using CO2 monitors in classrooms and lunch areas to gauge air quality and COVID transmission risk, as aerosol experts have recommended?
		The CDC's K-12 Schools COVID-19 Mitigation Toolkit HVAC checklist includes the following questions. How many of these actions has D205 completed and where can this information be found?
		1.Has the heating, ventilation, and air conditioning (HVAC) system(s) and/or unit ventilation equipment in all buildings (both permanent and temporary) been assessed and controls calibrated per manufacturer specification? Note: For detailed checklists for Janitors and Maintenance Staff and HVAC and School Facilities Staff see Appendix A.
		2.Has an HVAC maintenance technician or HVAC professional changed building air ventilation according to CDC and ASHRAE guidance?
		3.Has local exhaust ventilation in restrooms and other high occupancy areas been assessed?
		4. Was ventilation through other means considered when HVAC adjustments were not possible? Portable high-efficiency particulate air (HEPA) fan/filtration systems to help enhance air cleaning can be considered in areas of higher risk such as the nurse's office and isolation rooms
		5.Has ultraviolet germicidal radiation (UVGI) been considered as a supplement to help kill SARS-CoV-2, especially when increasing room ventilation options are limited?
		6.Is there a plan to leave windows and doors open to increase air flow from outside? Note: Ensure opening windows and doors does not create safety or health hazards (e.g., exacerbating asthma symptoms or other symptoms of respiratory illness). Have bus operators been instructed to leave windows open, when doing so does not create a safety or health hazard?

Why is the District looking to add change again in a few weeks by going 5 full days for the last 6 weeks? Teachers, administrators, families, caregivers just developed a plan to handle the current schedule, and then have to make further changes for the last few weeks of school. The schools are 80% Reopen and 20% Virtual – with saliva testing - that's a huge transition already from 2 weeks ago. 1 more day in person will not add to the academic rigor over 6 weeks, so why is the District ONLY listening to the few parents demanding "full reopen" despite the facts: 1) With the introduction of saliva testing, Sandburg middle school's first week results revealed much higher numbers of asymptomatic cases of Covid infection- and I suspect the other schools showed the same. 2) Teachers are not yet fully vaccinated and the District hould assure that they are before pushing further interaction and increases in infection 3) CDC guidance says distance of 6 ft. distance yet the District has gone to 3 ft. – increasing exposure—why increase time exposure as well? 4) There is no good plan for kids to eat lunch indoors at this time. Why introduce this extra variable as well at this time? 5) Community case rates have declined, for now.
