Pledge of Allegiance: Board members led those present in reciting the Pledge of Allegiance.

Spotlight/Recognition

<u>Shining Star Recipient – Erendia Navarro</u>: Mrs. Trautmann introduced Erendia Navarro as the Shining Star recipient for her Elmhurst community volunteer work especially with the Elmhurst Resource Collaboration group. She coordinated one of Elmhurst's biggest resource fairs in July. The resource fair hosted a variety of agencies, medical providers, offered students school supplies, provided families with food boxes, and assisted our parents with school registration.

<u>Family Career Culinary Leaders of America (FCCLA) National Winner</u>: York High School students were recognized for their silver and gold medals received during the FCCLA's first-ever hybrid national leadership conference. Mrs. Hosler read the proclamation recognizing the students and the faculty of the Family and Consumer Sciences department. The board applauded the parents for their support, too.

Ten guests provided public comment to the Board. Facilities Update

Mr. Schmidt presented the Facility Update of the summer 2021 construction. He reviewed an updated referendum budget. As a reminder to the community, the Board commented that there was an intentional

increase in the scope or work for future growth, which caused an increase in cost but reiterated that for future projects, the team should be mindful of cost containment without compromising student experience. Mr. Schmidt continued to review the progress on Lincoln ES, Transition Center, and York storm water storage/new turf area, along with updates on the completed projects at Edison, Emerson, Hawthorne, and York's pool area. The Board mentioned the wonderful way Edison's old and new areas were incorporated together. The board asked if there is a possibility that an open house could be set up for the community.

SY 21-22 Opening Week Celebration

Mrs. Redmond introduced the fall 2021 Moving Forward Together start of school celebration. It was a strong start to the year with: Five Full Days of Instruction for All Students in All Schools; Connection, Communication and Cultivating Positive Relationships Across the D205 Community; and Celebrate the Strength and Demonstrate Pride in D205 Students, Staff and Schools. The school year began with teacher institute days, followed by back to school events. President Caforio thanked Dr. Campbell and the team for the special 2021 opening teacher institute day event.

Action Item

Approval of Teaching and Learning Consultant Contract

Dr. Campbell indicated that contracting with a consultant will allow the administration team time to appropriately recruit and hire a permanent leader to fill the vacant assistant superintendent of teaching and learning role. The recommendation as the interim superintendent of teaching and learning is Dr. Sanford. The board asked if the one-year contract is firm, if there is a limit on the number of days the consultant can work, and what the timeframe is to begin the search for a permanent replacement. Dr. Campbell stated the search would most likely begin in December with the goal of offer to hire in the spring and included that TRS is not a factor in the number of work days.

President Caforio asked for a motion to approve the consultant contract with Dr. Sanford. Mrs. Hosler moved and Mrs. Caforio seconded the motion. **ROLL CALL VOTE**: Mrs. Hosler, Mrs. Trautmann, Mr. Collins, Mrs. Arvanitis, and Mrs. Caforio voted aye. Motion carries. Mrs. Stuefen and Mr. Kocinski were absent.

Superintendent Communication
